What is the GDPR?

The GDPR is a regulation intended to strengthen and unify data protection for all individuals within the EU. It aims to protect the fundamental right to privacy and the protection of personal data.

What type of information do we collect?

We, at Roberta Mason Art Glass, receive, collect and store any information you enter on our website or provide us in any other way. In addition, we collect the Internet protocol (IP) address used to connect your computer to the Internet; e-mail address and connection information. We may use software tools to measure and collect session information, including page response times, length of visits to certain pages, page interaction information, and methods used to browse away from the page.

In almost all cases we will only ever contact you following initial contact by you or following provision of personal information by you. We use and store your personal information in the following ways:

How we collect information?
